RESOLUTION AUTHORIZING BRADLEY COUNTY MAYOR TO NEGOTIATE AND
ENTER INTO A ONE (1) YEAR AGREEMENT WITH NEWTERRA COMPOST, LLC FOR
THE INSTALLATION OF A COMPOST COLLECTION KIOSK AT THE BRADLEY
COUNTY FARMERS MARKET NORTH LOCATED ON URBANE ROAD**

WHEREAS, NewTerra Compost, LLC has proposed to provide for the installation of a compost collection kiosk at the Bradley County Farmers Market North; and

WHEREAS, the term of the Contract shall be for a period of one (1) year and installation and maintenance shall be at the sole cost and expense of NewTerra Compost, LLC in exchange for making the composting assessible to Farmers Market vendors.

NOW, THEREFORE, BE IT RESOLVED by the Bradley County Legislative Body meeting in regular session at Cleveland, Tennessee, on this 7th day of March, 2022, that:

SECTION 1. Bradley County Mayor be and is hereby authorized to negotiate a one (1) year Agreement with NewTerra Compost, LLC for the installation of a compost collection kiosk at the Bradley County Farmers Market North.

SECTION 2. Bradley County Mayor be and is hereby authorized following successful negotiation to enter into a one (1) year Agreement with NewTerra Compost, LLC for the installation of a compost collection kiosk at the Bradley County Farmers Market North enabling vendors to compost unsold items.
