RESOLUTION TO REZONE FROM FAR
FORESTRY/AGRICULTURAL/RESIDENTIAL DISTRICT TO R-4 RESIDENTIAL
MOBILE HOME PARK AND TRAVEL TRAILER PARK DISTRICT PROPERTY
LOCATED AT 507 UPPER RIVER ROAD NE AND IDENTIFIED BY TAX MAP:
022 PARCEL: 009.00**

WHEREAS, Billy Thomas petitioned the Bradley County Planning Commission to rezone from FAR Forestry/Agricultural/Residential to R-4 Residential Mobile Home Park and Travel Trailer Park property located at 507 Upper River Road NE and identified by Tax Map: 022 Parcel: 009.00 and said Planning Commission on May 19, 2022 recommended approval of the rezoning request;

WHEREAS, Billy Thomas requested that the Bradley County Commission consider said petition and notice has been published in a newspaper in general circulation in Bradley County and that the County Commission will hold a public hearing on June 20, 2022 concerning the passage of this Resolution as required by law, and such hearing having been held.

NOW, THEREFORE BE IT RESOLVED by the county legislative body of Bradley County meeting in session at Bradley County, Tennessee, on the 20th day of June, 2022 that the zoning map of Bradley County, Tennessee be amended to rezone from FAR Forestry/Agricultural/Residential to R-4 Residential Mobile Home Park and Travel Trailer Park property located at 507 Upper River Road NE and described in Deed Book: 2892 Page: 602, Bradley County Register of Deed's Office and identified Tax Map: 022 Parcel: 009.00 as shown on the attached map.
