RESOLUTION 2021- _____
RESOLUTION FIXING THE COMPENSATION OF THE MEMBERS OF THE BRADLEY COUNTY BOARD OF EDUCATION WHEN ATTENDING REGULAR AND SPECIAL MEETINGS AND DISCHARGING THE DUTIES IMPOSED BY TITLE 49 OF THE TENNESSEE CODE ANNOTATED

WHEREAS, the Bradley County Board of Education is created pursuant to the authority set forth in Bradley County Private Acts of 2002, Chapter 163, and Tennessee Code Annotated § 49-2-201 *et seq.*; and

WHEREAS, Tennessee Code Annotated § 49-2-202 provides that the compensation of the county board of education shall be fixed by the county legislative body for their services when attending meetings; and

WHEREAS, Bradley County Board of Education members are currently receiving compensation from the Bradley County School budget in an amount of two hundred dollars (\$200.00) per month for regular members and four hundred dollars (\$400.00) per month for the Chairperson since approximately 1993; and

WHEREAS, the Bradley County Schools have requested that the compensation paid to the Bradley County Board of Education be increased beginning in July of 2021.

NOW, THEREFORE, BE IT RESOLVED by the County Legislative Body of Bradley County, Tennessee, meeting in regular session on this ___ day of _____, 2021 that the compensation of the members of the Bradley County Board of Education be increased to an amount of six hundred dollars (\$600.00) per month for all regular members and eight hundred dollars (\$800.00) per month for the Chairperson of the Bradley County Board of Education to be paid from the budget of the Bradley County Schools beginning in July of 2021.

BE IT FURTHER RESOLVED that beginning in July of 2022, the compensation of the members of the Bradley County Board of Education shall be regularly increased each year from the amount set forth above by the same percentage increase each year that is given, if any, to Bradley County employees.

BE IT FURTHER RESOLVED that this Resolution shall take effect upon passage, having been properly signed, certified and meeting all other legal requirements of the Bradley County Commission, and as otherwise provided by law, the public welfare requiring it.
