## **RESOLUTION 2021-\_\_\_\_**

### **RESOLUTION APPOINTING MEMBERS TO THE BRIAN K. SMITH WORKHOUSE DISCIPLINARY REVIEW BOARD AND THE WORK RELEASE COMMISSION**

**WHEREAS**, on July 17, 2017 the Bradley County Commission adopted Resolution 2017-33 declaring the Brian K. Smith Workhouse as a separate workhouse to be operated under the administrative control of the Bradley County Sheriff, establishing the workhouse Disciplinary Review Board, instituting a work release program at the workhouse and creating a Work Release Commission, establishing the order of disbursements from the wages or salary of employed prisoners, establishing other additional workhouse charges, and authorizing the Sheriff and Mayor to enter into a memorandum of understanding; and

**WHEREAS**, updated appointments to the Workhouse Disciplinary Review Board are necessary for the continued operation of the work release program; and

**WHEREAS**, updated appointments to the Work Release Commission are necessary for the continued operation of the work release program.

**NOW, THEREFORE BE IT RESOLVED** by the County Legislative Body of Bradley County meeting in session at Bradley County Tennessee, Tennessee, on this \_\_\_\_ day of August, 2021, that:
