### REPORT FROM COUNTY MAYOR

County Mayor D. Gary Davis presented to the Commission a resolution authorizing Bradley County Mayor to negotiate and enter into an agreement with Sport Surface Pros, LLC to resurface two existing tennis courts located at the Bradley County Recreational Park for an amount of nineteen thousand three hundred dollars (\$19,300.00). Commissioner Louie Alford placed the resolution on the August 17, 2020, voting session agenda.

1st District
